

Welcome to Hogan's Alley Paintball. Listed here is the information you need to have a great day of paintball.

**What to wear:** Long sleeve shirts and long pants are required. You should have footwear appropriate for running on varied terrain. Footwear should provide traction and ankle protection is recommended. Gloves make the game more enjoyable, anything that covers the knuckles is fine. Kneepads and elbow pads are recommended for people who play aggressively. Raingear is a good idea if the forecast calls for rain.

**What to bring:** Completed paperwork from the packet, a camera, and some excitement.

**Check in:** Arrive at least 45 minutes prior to your play time for check in, rentals, and orientation. Proceed to the sales counter on your left when you arrive and speak to a group coordinator. The coordinator will collect your paperwork, hand wristbands out for the participants, and finalize payment. You will then be directed to rentals.

**Rentals:** From the counter you'll line up on the silver line leading to the rental room. As each person gets their gear they will exit into the picnic area where orientation will commence once the whole group has arrived.

**Orientation:** Your party pro will provide an explanation of the rules provided in the rental packet, a demonstration on how to use the gear provided, and an overview of how to play paintball. After orientation the first game will start.

**Games:** Games will be played on different fields throughout the day. Usually, we play at a rate of 2 games per field, followed by a short break.

**Check out:** After your last game your party pro will take you back to the silver line in the store to turn in the gear.

**After the game:** Hogan's Alley has vending machines on site for beverages and catering is available through many of our partners. There is no outside food allowed, but you can bring drinks to stay hydrated. A menu is provided in this packet with some food options. Call us if you don't see what you're looking for. If you purchased a food package your party pro will have a table set up for you and help serve the guests.

**Do Parties Tip Their Party Pros?** Yes, if they do a great job – 10% of the party total before tax is standard.

From 91 Heading North: Exit 17, Follow signs to RT 15N Berlin Tpke \*


From Merrit Parkway Heading North: Merrit pkwy turns into the Berlin Tpke \*

From 691 Heading East: Exit 7, go straight through 2 stop signs. At stoplight turn left onto North Colony Rd. We are 1 1/4 miles on the left.

From 691 Heading West: Exit 7, Bear right. Turn left onto Center St. Proceed through traffic light. At end turn RT onto North Colony Rd. We are 1 mile down on your left

\* **From the beginning of the Berlin Tpke.** At the 2nd set of traffic lights take a left onto North Colony rd. We are 1 1/4 miles down on the right.

We are 998 North Colony Rd. It's a very large building with a well-lit road sign. You can't miss us. For directions from elsewhere call us at 1-800-916-1500.

# Player Safety Rules

All players and spectators must read and follow all safety and game rules without exception. Any violation of these rules will result in player or spectator ejection from the field of play or the premises.

- 1) Approved **Full Face Mask/Goggle Systems** must be worn at all times on the field.
- 2) No shooting into or out of the staging area, parking area, or neutral zones.
- 3) No dry firing in the parking lot or staging area due to a city noise ordinance,
- 4) **Barrel plugs must be in at all times when in staging, store, parking lot and on the field in between games. Barrel plugs** are not squeegees, or rags, or towels.
- 5) Do not shoot the wildlife, trains, referees, spectators, etc.
- 6) No climbing trees or on top of structures.
- 7) No physical contact.
- 8) No potentially dangerous gear. Players may not bring any form of tools onto the playing field. No types of firearms, pyrotechnics, or explosives are allowed. The game site operator must approve all personal equipment.
- 9) Avoid field hazards.
- 10) Construct no booby traps.
- 11) No alcohol or illegal drugs are allowed on the premises.
- 12) No verbal abuse.
- 13) Do not remove the power source (tank) or any other parts from the rental guns.
- 14) No blind shooting. Players may only shoot what they can see.
- 15) Judges decisions are final. No players will be allowed to argue with any judge.
- 16) Spectators must wear goggle/ full-face mask with ear protection also unless behind the safety net 10 feet.
- 17) Marker speed over 280FPS will result in ejection.
- 18) No enhanced triggers.
- 19) Trigger guards mandatory on all markers.
- 20) If you are hit during the game you must:
  - a) Yell as loud as possible, "I'M HIT!" or "I'M OUT!"
  - b) Immediately put your barrel plug in
  - c) Raise your gun over your head and immediately proceed off the field.
- 21) No Bunkering (no shooting another player closer than 20 feet)
- 22) Long Pants and Long sleeves are required. Knee pads are *required* if you intend on sliding, otherwise kneepads are strongly recommended.
- 23) Players will be ejected for wiping off paint or playing through hits
- 24) Players with field paint only colored wristbands must use field paint only. Violators will be immediately ejected.
- 25) We are not responsible for your personal possessions, please keep your cars locked, and an eye on your gear at all times.
- 26) Players must wear wristbands around the wrist snug enough not to fall off.
- 27) No portable fill stations allowed on site.
- 28) Management reserves the right to eject any player without refund at its discretion.
